Hereby you receive our response on your non legal fraudulent blackmail d.d. 6 aug. 2018

You have accused Singularity and our partners of NON realistic matters. (we noticed you also did at other NLS companies like Diacom, DKG, a.o.chinese)

By directly contacting our partners, you did damage to the good name of our company, name, partners, products and services.

You also did fraudulent and chantage actions and falsifications. You illegally dare to ask us and our partners for our sales, contact info of cliënts, and other not permissible, It is absurd behavior. Only criminals behave this way. We have our contacts.

**A rule is “Who accuses does have to bring proof”, FIRST, that is an international law, written and unwritten. There are also other laws to consider.**

Your print taken from our website “illegally”, are NO proof, it’s the opposite non-proof. They proof our own products and trademarks.

To enlighten you;

Singularity has never used the trademark “Vector”or “Vektor”, Diacom, Diacom-usa or Biostar NLS. So in fact, we do not need to defend ourselves.

Singularity delivers their own created software and hardware wich is far more sophisticated than others.

Since some of our partners buy\work also with SSCH aka Dolma industries (very well know by you since you use their products too) there might by a mixup !

SSCH aka Dolma Industries delivers Vector Expert with their 8D Lris DNA device. Not Singularity.

But since you really crossed all lines of normal business behavior, like your father did, you family does for many years, (just remember the FDA cases, Diacom, Vector NLS / DKG etc.), we will enlighten you and your father and provide your Biostar family 1 more chance to change.

First of all, Singularity was formed many years before even Biostar NLS was formed. Biostar was formed by your father Ulysses Angulo just recently in April 2015 (see his linkedin profile <https://www.linkedin.com/in/ulyssesangulo> ).

Singularity has its own NLS hardware devices developed by her team of specialists engineers worldwide.

Our NLS hardware is not to be compared since we are 10 years ahead in development upon others. Your email consists of really outrageous accusations from you and have no ground to do so. Singularity has its own NLS software versions developed by her team of Russian and Chinese developers and programmers in many other languages. Our NLS software is not to be compared since we are 10 years ahead (or more) in development upon others.

Singularity has its own legal trademarks in NLS, hardware and software. Singularity really has NLS specialists and has cooperation \ is influenced by many scientists and professors worldwide.

Yes we did see your hardware and your software on your websites. It is like comparing a Daihatsu Cuore with a Mercedes. You are 10 years behind. Also your "first" new to bring in 2019 VECTOR device is a faulty one. The imprinting cup on the device is metal. This will never work.

Biostar NLS has never developed NLS hardware or NLS software. Biostar NLS has only copied and used production facilities in China to produce the parts wick then are assembled to avoid tax. Biostar also uses the products of other companies like SSCH and others. And puts a logo of Biostar NLS on it. Or changes the case. That's all. We are also informed and very aware that "**a former worker**" at DKG Vector NLS Bioresonance, has **stolen** the software at DKG and went working for YOU. Biostar NLS has also stolen the "Certificates" , the numbers refer to a legal case with the same Certificates in lega issue DKG and Diacom (the real) **2011/10982** (not realizing that DKG aka Vector NLS Bioresonance ALSO previously did flasifications with numbers on this Certi docs as proven ilegal by Diacom \ pres. All Biostars activities are based/started after the PENDING of the trademark “Vector”, in recent JULY 2018 ! So all your actions are illegal based on lies. It is not active !

“In short, nobody has the rights to the intellectual property of any software in the world for **NLS** biofeedback systems. Or Vector.

If somebody did they would have long ago closed 80% of the companies that are out on the market including Biostar”. A message from the originator in Russia.

Vector is 30 years ago registered worldwide by [www.vector.com](http://www.vector.com) with almost the same logo. A company with 20 companies worldwide with a good earned reputation (not stolen or forced).

“A trade mark” gives no rights on a product, service, software, intellectual, physical. Coca Cola makes cola, many others do. Mercedes makes cars, many others do. Etc.

“A **pending trademark**”, gives NO rights at all on -> USAGE now “as you do”, is not legal -> no Rights of Ownership – no Software copy rights – no Software License rights - no Hardware rights – no Products rights” not on “Intellectual property”, and certainly of the case of Biostar NLS, NO rights on a good name.

Biostar has no “Rights of ownership” on NLS, or Vektor, or Vector.

Biostar has no “product rights”

Biostar has no “rights of distribution”

Biostar has no “rights in an **agreement** with Vektor Russia”, and also certificates are falsely used.

Biostar used a false **Post Office adres** in Russia for **Vector ltd Russia**. “Building 106” is false. The

real address is LLC "VECTOR" (Zelenograd) 124498 Moscow, Zelenograd, building 426A.

Biostar has a website <http://www.vector-nls.ru/> with false certificates without any sign of an agreement and NO mentioning of Biostar NLS !

This is the real website <http://vector-nls.ru:80/index/stoimost/0-9>

And registered ....only since **Registration Date: 2018-05-29** Expiration Date:2019-05-29 So who is fooling who ?? !!

Biostar NLS does not have the proper legal rights to do so. You are running ahead with all your actions before the first legal steps are done.

Vector is not registered in Russia. It was Bektov/VEKTOR with a **K**. And **\*only for the Russian Market** by these \*registration docs (or so called certificates) and not for Biostar NLS, not anywhere else.

Certificates wich you have stolen and put diagonal on it Vector NLS with pdf maker. But again, you have no right , you have only a “pending trademark”

The proof of the doctor on your website is no proof, he is not the originator, he is a doctor who worked for years with “different” nls systems, that’s all. He does not mention Biostar or Vektor.
